Families First – assessment numbers





Family First Assessments (FFAs) are used to identify support for families who agree to multi-agency early help.



The number of FFAs finalised in the 12 months to the end of March 2023 was 658, which included 1,541 children. 28.2% of children supported are non White British. 11.2% of children had an EHCP.



Intensive Family Support teams (348) and schools / school partnerships (184) led on the majority of FFAs.



Between April 2022 and March 2023, 1,275 children were supported using 'short term work' interventions. Family Centres provided targeted support to 1,106 families using the Family Centre targeted workflow during the same period.

Presenting needs and outcomes





77% of FFAs include at least one adult member of the family with a need. Over 60% of FFAs include issues about child health, Family relationships and education concerns.



The most frequently recorded primary needs for children are unmet mental health / emotional wellbeing needs, behaviour and family relationships.




The outcome success rate following the completion of FFAs for the period between April 2022 and March 2023 was 73%. 17% of families disengaged or withdrew consent; however it is often found that much has been achieved prior to disengagement. 9% of FFAs result in cases transferred to LCS for support from Specialist & Safeguarding Services.












Number of families aggregated across the Districts is marginally higher than total number of families as some families are split and live in different Districts.

(county increase from 1.9% - 2.6% between March 2020 & Apr. 2023)




Watford has the highest claimant count rate, as of April 2023, at 3.6%; East Herts & St. Albans have the lowest rates at 1.9%. The Hertfordshire rate for 18-24 year olds is 3.3% (April 2023); this was 2.7% in March 2020.

In addition to the NEET rate increasing from 2.0% to 2.4% in the last 12 months, the in-learning rate has fallen during the same period from 93.9% to 93.5%. The lost contact fell from 1.44% in 1.28%. NEET rates for our vulnerable groups are significantly higher, hence the investment in initiatives for targeted support.
